Service Agreement & Contract for Dog Daycare & Boarding

I, _____, agree to the company Policies and Procedures as well as the following relative to my dog's care at Dachs 2 Danes, Inc. (D2D) doggy daycare.

1. I certify that my dog is current with the following vaccinations: Rabies; DHLPP; Bordetella (required every year). I agree to keep all vaccines current while my dog is in the care of D2D. I further understand that even though my dog is vaccinated for Bordetella (to protect against Canine Cough, a.k.a. Kennel Cough), there is a chance that my dog can still contract Canine Cough. I agree that I will not hold D2D liable if my dog contracts Canine Cough. _____ (initials)
2. I understand that my dog be at least 3 months of age and have started their rounds of puppy shots to be cared for at the D2D daycare facility. _____ (initials)
3. I understand that a fecal exam, done by a licensed veterinarian, is required prior to my dog's first day interview and once every year after while receiving care at D2D daycare facility. _____ (initials)
4. I understand that it is required that my dog is on a flea control program. If any fleas are found on my dog, I authorize D2D to apply either Frontline or Advantage and understand that there is a charge of \$15.00 per application, unless flea control medicine is already provided and scheduled for application. _____ (initials)
5. I have disclosed, and shall continue to disclose on an on-going basis, any and all medical conditions or other conditions, including but not limited to personality concerns or behaviors that may affect, limit or prevent my dog's ability to participate in play time or otherwise attend D2D daycare. _____ (initials)
6. I understand participation in play time is at the sole discretion of D2D and that my dog may be separated from other dogs or asked to leave for any reason. _____ (initials)
7. My dog is not aggressive. I understand that aggressive dogs are not permitted to attend D2D daycare and that if my dog acts aggressively or exhibits unacceptable behavior he/she may be separated from the other dogs or asked to leave the facility. D2D will make reasonable efforts to consult me about aggression and ways to address it, however aggressive dogs may be asked not to return to D2D's daycare facility. Such determinations shall be made at the sole discretion of D2D. _____ (initials)
8. I acknowledge and understand that there are inherent and potential risks involved with interaction between humans and dogs, as well as between dogs and other dogs, which may result in property damage or bodily injury, including but not limited to permanent disability, sickness or death to human or dog. I agree that if my dog is the cause of any injury or death to another animal or human, or the cause of damage to the property, I shall be fully and legally responsible for the cost of any such injury, death or damage. I agree to fully indemnify D2D, it's principles, employees, agents, representatives, successors and assigns for any costs, losses or legal expenses incurred in the defense of any personal injury or any other claims, including claims for negligence, brought by myself or a third party arising from or related to my actions or the actions of my dog while on the premises or in the custody of D2D. I have read this paragraph and understand the consequences of any aggressive/destructive behaviors of my dog. _____ (initials)
9. I, or my homeowners insurance, will be responsible for any injury (i.e. dog bites or scratches requiring medical attention) to D2D principles, employees, agents, or representatives due to my dogs actions or the condition of my house/premises. _____ (initials)
10. D2D's sole responsibility with regard to my dog is to act with reasonable care. If my dog becomes ill, injured, dies and/or escapes while in the custody and care of D2D (whether such illness, injury or death is discovered while in the custody of D2D or afterwards), I agree that if D2D acted with reasonable care, I shall not bring any claim, suit, or action of any kind against D2D arising out of the illness, injury or death of my dog. Like children on a playground, I

fully realize that illness/injury can happen when a group of dogs are playing together (even when supervised). I further understand that if my dog has the ability to jump or climb a fence 6 feet high, I am liable if my dog escapes.

11. I authorize D2D to arrange emergency veterinary care, releasing D2D from any and all liabilities relating to transportation, treatment, and expense. Should my specified veterinarian be unavailable, I authorize D2D to engage the services of a veterinarian of their choice. _____ (initials)
12. In the event of a medical emergency, I give permission to D2D to approve treatment up to \$ _____. I understand that D2D will make an initial effort to contact me regarding any treatments, illness, injury, or potential problems as soon as possible. If D2D is unable to reach me, D2D is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. I agree to reimburse D2D for any expenses incurred plus any additional fees for attending to this or any expenses incurred for any other pet food, supplies, or additional care needed. I further understand that D2D and its staff assume no responsibility for the actions and decisions of the veterinary staff, the health, or death of my dog. _____ (initials)
13. When participating in daycare, if my dog is not picked up by the end of the business day, I authorize D2D to take whatever action it deems appropriate for the continuing care of my dog, such as boarding overnight. I further agree to pay the cost of such care as provided by D2D upon demand. _____ (initials)
14. I agree that I will not neglect to pick up my dog from the D2D daycare facility by the time he/she is scheduled to leave without providing notification. Any dog that is left in D2D's custody without any contact, instruction or notification from me, of the ability, willingness, or plans to pick him/her up myself or by my personal representative or agent, will be considered abandoned on the seventh day of such notification failure. I understand that if I abandon my dog, D2D will, by default, become the legal owner and guardian of my dog. D2D will, in its sole discretion, determine whether to try to rehome and adopt my dog from the D2D location at which he/she was abandoned or will relinquish my dog to an unrelated shelter of its choice. I fully understand and agree that if I abandon my dog at the D2D daycare facility, I may be unable to retrieve possession of my dog and will have no recourse against D2D. _____ (initials)
15. I understand that for me to watch my dog playing at the D2D daycare facility, live video feed will be available to the public, online through the D2D website and in the facility lobby. I agree to allow D2D, its owners, employees, officers, directors, and agents to use my dog's name and any images or likeness of my dog taken while he/she is in the custody and care of D2D, in any form or format, for use, at any time, in any media, marketing, advertising, illustration, trade or promotional materials. _____ (initials)
16. I authorize my veterinarian to release all information regarding the status of vaccinations and FECAL EXAMS for my dog. The vaccinations that are required by D2D are DHLPP, RABIES and BORDETELLA. _____ (initials)
